CALL TO ORDER

A quorum being present Mayor Bartlett called the meeting to order at 4:35p.m.

PUBLIC WORKS/WATER RESOURCES

Minutes of a meeting held on March 19, 2024, were enclosed for council's perusal.

Tenders for the purchase of chlorine & soda ash were received from Brenntag Canada Inc. and the supply of town insurance from Cal Legrow.

The tender from Brenntag Canada Inc. is passed over to the Finance Committee for review and Councillor Rumbolt will review the insurance tender to make a recommendation at our next regular meeting.

Catalina Seawall

The Town Manager advised that because the original estimate did not meet the design intent, the new estimate provided was well above the original amount.

Multi-purpose Court

Deputy Mayor Lodge advised that we received \$10,000 in funding from the Department of Tourism, Culture, Arts and Recreation's Active NL Fund Program for the multipurpose court resurfacing, tennis net, and pickleball. The estimate for phase 1 of the project amounted to \$34,025. He stated the Recreation Committee wants to complete the project using its own funds and continue to fundraise but would request some financial assistance from other local organizations and the town.

Deputy Mayor Lodge advised that a volunteer approached a member of the Committee wishing to donate wood and time to fix the stairs at Lookout Park.

Mayor Bartlett stepped out of the chair at 5:25p.m. Deputy Mayor Lodge assumed the chair.

Mayor Bartlett resumed the chair at 5:30p.m.

Liability was the biggest concern that arose from the discussion.

Canada Summer Jobs Program

Deputy Mayor Lodge advised the TBN Recreation Committee was successful in acquiring six (6) positions under the Canada Summer Jobs Program.

FIRE DEPARTMENT

Minutes of a meeting held on March 25, 2024 were enclosed for council's perusal.

Councillor Rumbolt declared herself in conflict as her son is the Fire Chief and excused herself @ 5:32p.m. to sit in the gallery.

Councillor Stead expressed concern that members of the Fire Department believe that he had not provided a draft budget planning format since December of 2023 and that despite two emails directly to the Fire Department to provide the material and correct the misunderstanding, he had not received a response. He understands there may be an issue with email addresses and further explained that he had provided the draft format to the Town Manager in July and again in December of 2023. He emphasized that the Town Manager had agreed to provide the information with explanations to the Fire Chief on both

occasions and had agreed to work with the Fire Department to develop a budget plan for Council review on multiple occasions since July of 2023. Councillor Stead asked that the Town Manager confirm that the Fire Department has received the material and follow through on his commitment to work with them on their budget proposal for council.

Councillor Stead expressed concern with a comment in the minutes of a Fire Department meeting which seemed to indicate a false belief by the Fire Department that council intended to remove the Little Catalina Community building from the town's inventory. He explained that to his understanding there had been no discussion of any council intent to give up this community building. He asked to confirm council's long-term intent, and all agreed that while there was some discussion on possible amendments to how it's heated and what the overall use would be, there is no intent for the complete removal of Fire Department assets or any intent for giving up the building. Councillor Stead strongly recommended that the Town Manager and Council liaisons take the necessary steps to clearly define and explain council's long-term intent for the building to ensure the obvious confusion is cleared up.

Councillor Rumbolt returned to her seat at 5:45p.m.
