## **Town Emergency Plan**

Councillor Stead reported that after a discussion of emergency services requirements at a recent Municipal Affairs training symposium, the Trinity Bay North Council is responsible for having an updated Emergency Disaster Plan submitted to the provincial Emergency Services department every 3 years and may be responsible for having a formal and written call-in procedure as part of our town Emergency Disaster Plan. He further believes that a formal "on-call system" may be a public safety requirement. Unfortunately, Town Manager reports indicate that despite resolutions of council to complete an updated Emergency Disaster Plan, it has never been submitted to the responsible government department and there has never been a formal on-call policy in place.

## Town Budget/Tax Structure

Councillor Stead explained the Town Manager reported that council has no approved Municipal Budget or Tax Structure. He also reported that the town's Gas Tax account could be frozen due to delays in getting responses to questions on suspected issues with information provided to the auditor. Councillor Stead is concerned that these financial management requirements remain incomplete despite council and staff being aware of the need for an amended budget since February of 2024, which was confirmed by Municipal Affairs advisors in March. There are also concerns that financial management training indicates that in some cases council is not authorized to expend funding without the prior approval of the Minister of Municipal Affairs, through a published operational budget.

#### **Provincial Roads**

Councillor Stead expressed great concern that two-thirds of the provincial government road in the area of the Post Office in Little Catalina is unsafe for public transit. He explained that there is not enough road left for a single vehicle to safely remain on the existing pavement. This unsafe condition has existed for years and has worsened in recent months to cause great concern for the safety of routine traffic like school buses and other physically injured and vulnerable users. The Mayor supported by Councillor Stead informed the Minister of Transportation of this concern many months ago and the Deputy Mayor supported by the Public Works Committee has informed executive staff of the Department of Transportation and Infrastructure of the deplorable condition of this section of road on multiple occasions over the past year without effect. Recently Councillor Johnson reinforced this concern and addressed it directly to the MHA through public media. Unfortunately, all of these efforts seem to have fallen on deaf ears and no effective repair has been completed.

Be it resolved the Town Manager send an email to the Regional Transportation Representative "carbon copy" the MHA and the Minister of Transportation and Infrastructure's Executive Assistant. The email must emphasize the obvious public safety concerns and the fact that the Department of Transportation and Infrastructure has failed to correct this situation despite the repeated requests for corrective action by this municipality. The Town Manager should make a clear and urgent request as one executive staff member to another for immediate action to resurface the pavement in the area. It is further required that the email be reinforced with pictures indicating the depth and breadth of the damage to the existing road surface.
